The following clarification is being made to the request for proposal for South End Avenue & West Thames Street Streetscape Design Services. It is a result of issues discussed at the pre-proposal conference held on March 10, 2015.

In response to several questions received at the pre-proposal conference relating to MBE/WBE participation goals, please see the clarification below.

BPCA has an overall goal of 30% for MBE/WBE participation in business opportunities in the performance of the above-referenced services. That overall goal is broken down into a 15% goal for WBE participation and a 15% goal for MBE participation. For the avoidance of doubt, each of the separate WBE and MBE 15% participation goals is applicable to all proposers, regardless of whether the proposer would satisfy the overall participation goal of 30% prior to any subcontracting, unless the overall 30% participation goal is satisfied with 15% WBE and 15% MBE participation. Proposers must use and document good faith efforts to meet each of the above MBE/WBE goals, including the equalization of MBE and WBE participation in the performance of the contract. BPCA encourages the utilization of minority-owned business enterprises and women-owned business enterprises and can assist prospective bidders with finding opportunities to achieve MBE/WBE participation goals.
