The Hugh L. Carey Battery Park City Authority (the "Authority") seeks a title company licensed in New York State to (i) provide a title search for two separate lots on the same block in Manhattan, each comprised of a condominium unit, and (ii) issue an owner's title insurance policy for the transfer of each of the lots. Each lot is being transferred to the Authority by a separate, private entity. Each lot will be insured in the amount of \$15,000,000, for a total of \$30,000,000. Subsequent to the transfer, the title company will record all deeds and applicable transfer tax forms. The Authority is issuing this solicitation pursuant to its discretionary purchasing authority under State Finance Law §163(6). This procurement opportunity is limited to businesses certified pursuant to Article 15-A of the New York State Executive Law.
