Battery Park City Authority d/b/a Hugh L. Carey Battery Park City Authority ("BPCA") requests proposals (individually a "Proposal" and collectively the "Proposals") from qualified firms, registered with FINRA and/or the SEC, to provide BPCA with Senior Managing Underwriter or Co-Managing Underwriter services in connection with the issuance(s) of revenue bonds by BPCA. It is intended that through this RFP, one or more firms that are gualified underwriters will be selected for inclusion on BPCA's Qualified Underwriter List ("BQUL"). The proposed bonds shall be issued to accomplish objectives which shall include, but not be limited to: (1) the refinancing and/or restructuring of outstanding debt; (2) securing financing for a portion of BPCA's Five-Year Capital Program – approximately \$80 million; (3) providing the most cost effective pricing and marketing of BPCA bonds; (4) maintaining its credit ratings and low cost of capital; and (5) matching debt and a hedging structure with asset life, with an efficient, flexible lien structure. A detailed scope of work for which the selected Proposer will be responsible is attached as Exhibit A (the "Work").

Minority-Owned Business Enterprises ("MBE"), Women-Owned Business Enterprises ("WBE") and Service-Disabled Veteran-Owned Business Enterprises ("SDVOB") are encouraged to submit Proposals.

Restricted Period

Proposers are restricted from making contact with anyone other than the Designated Contacts (identified below) during the period from the time of publication of this advertisement through approval of the procurement contract by BPCA (the "Restricted Period"). Employees of BPCA are required to record certain contacts during the Restricted Period, including, but not limited to, any oral, written or electronic communication with a governmental entity under circumstances where a reasonable person would infer that the communication was intended to influence the governmental entity's conduct or decision regarding the governmental procurement, and to make a determination of responsibility based, in part, upon any such contact. Failure to abide by this process may result in a finding of non-responsibility.

Proposers must document "good faith efforts" to provide meaningful participation by certified SDVOB subcontractors or suppliers in the performance of the awarded contract. For guidance on how BPCA will determine a Proposer's "good faith efforts," refer to 9 NYCRR § 252.2(s).

BPCA reserves the right to cancel or withdraw in whole or in part this RFP at its sole discretion. Proposers will be notified in the event the RFP is cancelled via the BPCA website.
